This will be a shorter prayer letter due to the urgency of one of the requests, but I do want to update you on recent progress and answered prayers.

We've worked to canvass just about all of Lakenheath Village (the town where the community centre is where we meet on Sunday), all of RAFs Feltwell & Mildenhall, and half of the rental housing just outside the base at Lakenheath. We plan to do the on-base housing in the next few weeks. Help us pray that the gospel will be received, souls will be saved, and that such will be added to the church.

Thank you for praying for our Sunday Knights Kids Club. We've enjoyed four weeks of it now and I'm very pleased with how smoothly it has operated and the efforts our children have put into memorising verses and learning songs for the December program. I pray that we get more families to whom we can minister.

This is our major request, and we desire that you lift this up urgently and frequently. Faith Baptist Church is able to pay some of our living expenses, and one of these is the electric & gas bill. The former missionary moved out in August and we were supposed to move in during September and were delayed until March, as you know. The church paid the bills (addressed to "Occupier") during that interim. Whenever a tenant search was made on the property after we moved in, we received our first bill in May for the full usage since August, which put us in arrears over £1,000, although the bill had been paid regularly and timely every month by the church. We addressed this with the energy company at least a dozen times, with assurances that it was being looked into, that it had been escalated, that our inquiries were being forwarded to the complaints department and other promises. Once the case is sixty days old with no resolution, we have the right to appeal to an ombudsman, which we have.

We have submitted our evidence (bank statements with payments made to the company that match the billed amounts), and the energy company has submitted theirs (which consists of nothing more than a statement that they cannot locate these payments within their system). I have closed my arguments and the energy company has another couple of days to submit theirs, then a ruling would be made. **Please pray that the ombudsman service rules in our favour**, which means that they have recognised that we have paid our bills and that the energy company has failed in their accounting. We do not want a bad testimony of unpaid bills or a negative mark on our credit report.

Thank you for your prayers, financial support, and correspondence by mail and e-mail. It means more than you'll know this side of heaven.
